


Small Business Pulse Survey: Regions Footprint

The U.S. Census Bureau's *Small Business Pulse Survey* is designed to measure changes in conditions amongst small businesses during the COVID-19 pandemic. First introduced in April, the survey is now in its third phase, which began the week of November 5 after a two-week hiatus. The questionnaire used in Phase Three is the same as that used in Phase Two. As in the first two phases, in Phase Three survey results are available on the national and state levels, as well as for the nation's 50 largest (based on population) metro areas, a group which includes 19 metro areas within the Regions footprint. Note that Phase Three of the survey has coincided with the ongoing surge in COVID-19 cases, and the effects of the surge and renewed restrictions on economic and social activity in a number of states are visible in the survey results. The latest survey period covered December 7 through December 13.

As seen in the top chart, there has been a marked increase in the percentage of small businesses reporting declining sales/revenues. Clearly, the share of businesses reporting declines at present is no match for those seen in the early phases of the pandemic, which comes as no surprise. Though not completely open, the economy is much more open now than was the case in the early phases of the pandemic. But, note that during Phase Two of the survey, the share of small businesses reporting declines in sales/revenues had pretty much stabilized at around 30 percent, while over the past three survey periods that share has topped 38 percent. At the same time, the share of small businesses reporting increasing sales/revenues has been below six percent during Phase Three, on par with the share in the very first week of the survey back in April.

There has also been deterioration in the labor market details of the *Small Business Pulse Survey*. Over the past five survey periods, the share of small businesses reporting an increase in the number of paid employees has hovered near the low point set in the first week of the survey in April. At the same time, the share of firms reporting a decrease in the number of employees over the most recent survey period has been rising. In the latest survey period, 12.6 percent of firms reported a decrease in the number of employees, the highest share since the second week of the survey. It is also important to track the total number of hours worked, or, the product of the number of people working and the number of hours they work in a given time period. Note that changes in total hours worked could reflect a change in the number of workers, a change in the number of hours worked, or some combination of the two. Over the past few survey periods, over 20 percent of small businesses report fewer total hours worked, higher than the share reporting fewer employees, which indicates business owners are also cutting back on weekly hours for at least some of their workers. So, while some workers are being let go, others are seeing their hours cut, which matters not only in terms of total labor input but also in terms of total labor earnings, the largest component of personal income.

We use the bottom chart to reinforce a point made earlier, which is that, while by no means as severe as the disruptions seen in the early phases of the pandemic, the recent surge in cases is taking a toll on the economy. While perhaps not severe enough to push the economy back into recession, the ongoing surge in case counts and new restrictions on activity are weighing on the rate of economic growth. And, with the surge not yet showing signs of slowing, the toll on the economy can be expected to rise in the weeks ahead.
